All puppies receive their first shot will be dewormed. Puppies shipped, will be examined by sellers vet and receive a certificate of health. Buyers has within 48 hours from puppies time of final day, or shipping arrival date, to have the puppy checked by a vet of his/her choice at the their expense.

If the buyer's vet exam reveals a genetic defect or that the puppy is diseased, the puppy must be returned at the buyer's expense and a replacement will be made when one becomes available.
